1. USE OF FACILITIES:

- 1.1. The Member shall be entitled to use Volare's gym facilities during normal operating hours.

2. MEMBER CONDUCT AND OBLIGATIONS:

- 2.1. Comply with all Volare's rules and regulations as displayed on the premises or otherwise communicated;
- 2.2. Use the equipment and facilities responsibly and in accordance with instructions provided;
- 2.3. Respect the rights, safety and comfort of other members and staff;
- 2.4. Return all equipment to its designated place after use;
- 2.5. Not use the facilities while under the influence of alcohol, drugs, or performance-enhancing substances;
- 2.6. Not bring any illegal substances onto the premises; and
- 2.7. Not engage in any form of harassment, intimidation or disruptive behaviour towards other members or staff.
- 2.8. The Member undertakes to provide Volare and its authorised agents with true and accurate details pertaining to the Member's health, weight, height, and any other relevant physical information, and agrees to undergo weighing, measuring or other basic assessments at the discretion of Volare's agents for safety and programme purposes.

3. INDEMNITY AND ASSUMPTION OF RISK

- 3.1. The Member acknowledges that engaging in physical exercise carries inherent risks, including injury or death, and voluntarily assumes all such risks.
- 3.2. The Member uses Volare's facilities entirely at their own risk and indemnifies and holds harmless Volare, its owners, staff and contractors from any and all claims, damages or losses arising from use of the facilities or participation in any activity on the premises.
- 3.3. This indemnity extends to any injury, loss or damage caused by the negligence of third parties or other members.

4. VEHICLES AND PERSONAL PROPERTY

- 4.1. Volare shall not be liable for any loss, theft or damage to any vehicle parked on or near the premises.
- 4.2. Volare shall not be liable for any loss, theft or damage to any item left in a member's vehicle parked on or near the premises.
- 4.3. Members are advised to ensure that vehicles and valuables are properly secured at all times.

5. TERMINATION

- 5.1. Volare reserves the right to terminate this membership immediately should the Member breach any provision of this Agreement or any house rule.
- 5.2. No refund shall be due upon termination for breach.
- 5.3. Volare may pursue legal action and claim damages in the event of any damage, vandalism, or loss caused by a Member to Volare's property, equipment, or facilities.
